1. Round 1: Group Discussion:

After Pre-Placement Talk, candidates were clear about the offer, role and responsibilities for each offers. 99 students appeared for the next selection process of Group discussion. In this step all candidates were tested on their confident, communication skill as well as detail knowledge about the topic. After this round of group discussion 54 students from SRLIM were shortlisted for next round of selection procedures.

2. Round 2: Personal Interview:

Personal Interview was conducted to evaluate attitude, to assess their knowledge about financial products such as Equity, Derivatives, Portfolio and Mutual Funds etc. After interview round, 24 candidates were finally selected from SRLIM, Surat.
